At the request of our attorneys – and considering these libraries contain our near priceless, SO IMPORTANT TO GUARD - nearly impossible to reproduce again; from scratch, vast armada or pre-recorded radio formats targeted vocals, radio staging beds, countdown materials, news intros, program openers, custom themes, novelty materials, wild and wacky effects, self 24/7 automated components – and much more! – We require 2 original hand completed copies of this 3 page license agreement form with original signatures - properly dated and fully completed – AGAIN NOTE: Other than the page 3 hand written Licensor/Licensee hand signature requirement – all required hand written information is to be NEATLY PRINTED IN BLUE INK - by hand – AFTER PAYMENT IS MADE - in coordination with Ben Freedman or Rob Hantson – This 3 page license form is Hereby REQUIRED FROM EACH LICENSEE to arrive for countersignature in our address in Plano, Texas (full mailing address - as seen under LICENSOR IN BOLD on page 2 of this agreement - at Licensee’s option via USPS Express Mail, FedEx, UPS (all of these insure fastest turnaround) NOTE – of course, if you return the TWO COPIES of this signed an dated library license agreement to Ben Freedman via USPS FIRST CLASS or 3rd CLASS Snail mail – after arranging advance full payment with Ben Freedman or Rob Hantson – THE LIBRARY DISCS YOU HAVE ORDERED AND PAID FOR – WILL OBVIOUSLY NOT ARRIVE AS FAST AS BY SENDING IN THE SIGNED LICENSE AGREEMENTS QUICKLY AND PROVIDING YOUR FedEx NUMBER OR PRE- PAYING FOR FedEx shipment of your library disc order or similar in order to ship the described Promo Library below (In USA – your countersigned file copy will accompany the library CD’s and/or DVD, Outside USA – your countersigned file copy will be snail mailed in a business envelope/due for obvious ease of customs clearance reasons.

WE APOLOGIZE –BUT - it is our policy NOT to ship out a Ben Freedman Promo Library CD Set or DVD unless full advance payment is made and approved

.RESCRICTIONS TO CONSIDER -In the case of Licensors' Promo Libraries, Licensee agrees when extracting audio elements by track number (for specific use by Licensee) to make careful note of the website GUIDE SHEETS listings of the published "regional and mile radius restrictions" thus, preventing conflicts (with DVD extractions - check the updated website GUIDE SHEET LISTINGS) RECAP -on the constantly updated CD GUIDE sheets you must REGULARLY CHECK THIS - www.promo-bank.net or www.instantradiostation.com (Licensee understands that minor errors do occur when considering the 99 year term of this agreement and yet it is well understood that the parties who infringe and Licensors do work together to hold to the "principals" involved in these ground rules in order to protect the technical requirements of both Licensee and Licensors. All described radio promo libraries are the copyrighted product of Licensors.. Ben Freedman.

- 1) **IMPORTANT NOTE (RULE/aka THE PROMO LIBRARY "PRIME DIRECTIVE")** - On all LINER SERVICE usage, or RADIO PRODUCTION HOUSE - or similar - As otherwise - these services - with these Licensors' libraries in house - have previously turned into competitive jingle companies themselves - THUS, all of Licensee's end user clients MUST - themselves - obtain with or without the assistance of Licensee - a hard signature and dated promo library license from Licensors in order to utilize Licensors' library materials for such pre-made constructed materials using Licensors' audio materials If Licensee's situation with it's clients are justified and not in high volume - Licensee may contact Licensors or your Sub-distributor for special exception requests in writing - in advance. .
- 2) **MASTERS** -Licensee will always retain the CD and/or DVD masters, make back up copies stored in a safe place, retained for future use under license terms/conditions. NO unauthorized copies will be made for any others under any circumstances EXCEPT for use on the intended programs, station or for Licensee's authorized users per the terms and conditions of this license. None of Licensors' original or station version safety copied full or partial work CD's or DVD's may be gifted, sold, assigned or licensed to any other parties what so ever. Including temporarily removal from their proper intended storage areas including Production room storage areas, internal or external hard drives
- 3) **COPYING** - Considering the restrictions outlines in #2 above - IN ADDITION:Licensee may not dub (copy) the promo libraries except for use in airplay or audio productions and not in the open on a way others could use the beds, elements or effects in any other productions - EVER. All jingle materials are the copyrighted product of Licensors and assignees. Licensee's audio products should be stored in the station's authorized store room areas and always be guarded SO THEY CAN NOT BE COPIED - including any traveling individuals claiming to be innocent collectors of audio materials made and utilized innocently by this particular collector of audio productions. THIS MAY BE A SCAM, NEVER DUB ANY OF LICENSOR'S AUDIO UNDER ANY CIRCUMSTANCES UNLESS IT IS FOR USE BY LICENSEE AND USED PROPERLY (AS DESCRIBED IN THIS AGREEMENT)..

- 4) **THEFT OF “BEDS & EFFECTS” IN PARTICULAR ALSO A SCAM!!** The Promo Bank beds or effects may not be “originally sung over” by any other singers than licensor’s singers. Yes, licensee may combine the PB materials with jingles from other jingle companies.
- 5) **RE-SELLING** Licensee may not resell (including on eBay or similar), gift or rebrand Licensor’s jingles, beds or all EFX to any other party.
- 6) **UNPACKING** Licensee will hand wipe/clean soft cloth and test play the discs immediately upon delivery and compare against the published GUIDE SHEETS for correct content and labeling. Should any defective or mis-labeled CD’s or DVD’s be discovered, contact Licensor ben@jingleguy.com to arrange immediate replacements and the immediate return of the defective product for evaluation and examination for defects,
- 7) **TANGIBLE CD OR DVD OWNERSHIP** The licensee agrees that the tangible CD/DVD discs are – and remain - the property of Ben Freedman (with possible return requested after client safety dubs are made) and are provided to licensee for dubbing use only and are considered the master copies for licensee’s use.
- 8) There will be no additional fees, royalties, residuals or renewals due to licensor – WHAT SO EVER - after the initial payment is made as described in SECTION B of this agreement - by Licensee to Licensor.
- 9) **99 YEAR TERM** This license will be for usage as described above and – for all promo libraries and ID jingles (with the exceptions noted further below) will be for a term of 99 years
- 10) **GENERAL USAGE:** usage of any or all of Licensor’s audio materials as described in this agreement page 3 of 3 may take place by Licensee’s stations described as on up to 7 local/regional commercial cluster stations, educational and/or institution stations, networks, and/or syndications; all providing that they are owned and directly controlled directly by Licensee and they are within one physical building and/or broadcast or originating within 75 miles radius from each other –THIS DESCRIPTION OF LICENSEE’S STATION “SET UP”, AND THUS, FACILITIES – IS HEREBY PERMITTED AND CONSIDERED AUTHORIZED IN RETURN FOR ONE PAYMENT AS DESCRIBED UNDER SECTION B ABOVE.
